The general feeling was that Juno Kata, although interesting was slightly esoteric and not relevant to the general practice of Judo as is indeed are the Nage-No-Kata and Katame-No Kata. Therefore it follows that as counter and combination techniques are introduced to the junior and senior syllabi at the 4 <sup>Th</sup> Kyu stage, the Kaeshi-No-Kata too, has a relevance to the general study and practice of Judo.

We believe the present system has led to a lowering of standard. And sadly we also believe it is open to abuse. It is understood that there is a caveat attached to the 'prequalification' mode that states; Prequalified Kata is subject, if deemed necessary, to validation.
